

What is the Shine for Him Project?

A Photographic Essay of Young People who have HOPE

The Shine For Him Project is a ministry that enables young people to make a photographic statement about their faith and hope in God, and provide a forum (website) to share their portrait and their testimony with the world.

It's FREE!

This ministry is not for profit. **Shine For Him Partner Photographers** provide services free of charge to young people, ages 7 to 21 to create unique and powerful portraits that illustrate their faith. Wallet sized portraits are provided at no charge to the student to share with others and the images are posted on the website, www.ShineForHim.com along with their testimony.

The goals and purpose of the Shine For Him Project is three-fold:

- 1. Encourage others (young and old) to be bold about sharing their faith in Christ**
Matt 5:16 Let your light shine before men in such a way that they may see your good works and glorify your Father who is in heaven.
- 2. Tell the world about the HOPE we have in Jesus Christ, through grace**
Mark 16:15 And He said to them, "Go into all the world and preach the gospel to all creation."
- 3. Set an example of what it means to have a relationship with God and live for Him**
1 Timothy 4:12 Let no one look down on your youthfulness, but rather in speech, conduct, love, faith and purity, show yourselves an example of those who believe.

A Bigger Vision

At this time, the SFH Project hosts a website where images of many young people may be viewed along with their testimony, and a gallery that is on display each year at Spirit West Coast (www.spiritwestcoast.org). But a broader vision is in the works...slide show presentations may be shown at churches, youth groups, and various functions with the message about "shining for Him", and other SFH products are being designed for gift purchases to support the ministry as well. Items include T-shirts, posters, calendars, mugs, jewelry, and notecards. The full scope of this project is yet to be revealed.

(Parents must sign if you are under 18.)

In consideration of the engagement as a model of the minor named below, and for other good and valuable consideration herein acknowledged as received. I hereby give SFH Partner Photographer, Peggie B. Hensley, Suzette Allen and "The Shine For Him Project" the absolute and irrevocable right and permission, with respect to photographs that he/she has taken of said minor or in which they may be included with others:

- To copyright the same in his/her own name or any other name the he/she may choose
- To use, re-use, publish and re-publish the same in whole or in part, individually or in conjunction with other photographs, in any medium and for any purpose whatsoever, including (but not by way of limitation) illustration, promotion and advertising and trade; and,
- To use said minor's first name in connection therewith if he/she so chooses.

How to Participate

To be part of the Shine For Him Project, you must be age 7-21. A portrait session will be scheduled with a SFH Partner Photographer in your area after submitting an application with your testimony and signed model release. We encourage you to pray about your special verse of the message you want to express through your portrait. A location for portraits is selected along with clothing and prop ideas and a time/date is scheduled for the portrait session. The portrait session specific to SFH is FREE (however there may be circumstances where it is part of a session with paid fees, (ie: a senior session where SFH is combined with a paid portrait session...)). You will be able to view the proofs and have input on the images chosen for the SFH image. You will also receive 24 FREE wallet portraits of your finished image. Additional prints are available for purchase, but there is no obligation to do so.

Appointments are generally scheduled on a space-and-time-available basis. Each person interested in participating must fill out an application form and a model release and write out their testimony prior to the photo session. Please fill out and detach the application and model release from this flyer, type out your testimony and bring along with you to your photo session. Portrait Guidelines

If you like, your SFH Photographer will help you choose the clothing for your portrait that complements you and/or the look you are trying to achieve. As a general rule, simplicity is best. Solid colors and long sleeves are also best choices. Please avoid stripes, busy prints and T-shirts with designs on the chest, as they usually distract from the subject (you) and the message! If the portrait is taken on location, a casual style is usually appropriate. Wear dark shoes, if possible, if you are wearing dark pants, and don't forget the dark socks! Many images are full length, so be sure at least one of your outfits looks good from head to toe. Ask your SFH Partner Photographer for suggestions or check the SFH website for examples or ideas of how to dress. Usually one or two outfits is all you need, and remember, Simplicity is the key!

There is no set number of exposures taken per session, however it is important that you receive the best and most creative effort. When your session is finished, it is with a feeling that your photographer has given their best, but we recognize that it is His anointing that creates a portrait that far exceeds our expectations.
